Both the sire and dam of this puppy have been DNA certified to establish the authenticity of this breeding. Each puppy leaves Spartan Kingdom with a certified DNA profile and micro-chipped with Home Again.

Spartan Bulldog Kennels guarantees the above described dog to be healthy at the time of the sale.

Spartan Bulldog Kennels does not assume any liability for any injury to said puppy after delivery.

The BUYER agrees to have this puppy examined by a veterinarian within 72 hours of delivery or the health guarantee is void.

If the puppy is found to be unhealthy by the BUYER'S veterinarian Spartan Bulldog Kennels must be contacted immediately so that appropriate arrangements can be made. Failure to contact Spartan Bulldog Kennels within 24 hours of the veterinarian's diagnosis will result in the guarantee being void.

All appropriate shots for the PUPPY'S age have been given, and a record of this vaccination history is supplied.

The BUYER agrees to maintain the puppy's health in good condition, and to provide annual examinations, vaccinations and any other usual procedures necessary to assure good health.

Spartan Bulldogs Kennels has done everything possible to produce sound healthy puppies by breeding only dogs that are stable, fit and in good health. Each breed pair is selected for their working ability, temperament, confirmation and pedigree.

We raise Spartan Bulldog puppies in the best way possible in regards to diet, exercise, socialization and veterinary care. Each puppy has been exposed to Von Falconer socialization program, bio sensory imprinting and a host of other environmental and physical imprinting.

There are many factors that can influence growth and development, such as diet, exercise and weight gain. The BUYER assumes the responsibility to carry on with the appropriate vaccinations, exercise and feeding schedule, as supplied by the BREEDER. ***MOST PARTICULARLY, the BUYER agrees to keep the puppy slim throughout its normal growth period.*** The BREEDER can offer no further guarantees once the care of the puppy is no longer under their control.

The BUYER agrees that neither he/she nor the BUYER'S estate/executors may sell this PUPPY or transfer ownership of this PUPPY without the BREEDER'S knowledge and written consent.

The BUYER hereby agrees that if at any time the Buyer cannot take proper care of the puppy, the BUYER must contact the BREEDER and the BREEDER will have the first choice to either: (a) take the PUPPY back or (b) assist the BUYER in finding a suitable home for the PUPPY.

The BUYER agrees to notify the BREEDER of any changes of address during the PUPPY'S lifetime.

The BUYER agrees to provide a suitable fenced area for this puppy.

The BUYER agrees to submit photographs of the dog to the BREEDER every six months for 2 years. i.e. 6 months old, 12 months old, 18 months old and 24 months old.

Spartan Bulldog Kennels reserves the right to breed any male pup produced twice at no charge from the puppy purchaser. All costs incurred by the breeding (semen collection, vet bills, travel) will be the responsibility of Spartan Bulldog Kennels.

All dogs produced by Spartan Bulldog Kennels will carry the SBK prefix in their registration papers and DNA profile.

As Spartan Bulldogs Kennels strives to preserve the working ability of the Alapaha Blueblood Bulldog with that objective we offer a 50% refund on the purchase price of any of our dogs that obtain a title in French Ring, Mondio, Schutzhund or PSA.

The BREEDER neither makes or implies any warranties or guarantees, express or implied, other than those written in the agreement including, without limitation, the warranties of merchantability and fitness. This document constitutes the entire agreement between the Breeder and Buyer with respect to this sale. The Buyer's signature below indicates that he/she has read, agrees and does understands all the conditions of the Sales Agreement and Contract of Sale.
